Description

ProCon-F-E fibrillated tape fiber products are designed to distribute quickly through the concrete matrix. Our fibrillated tape product is designed to optimize the mechanical bond between the mortar and the fiber. ProCon-F-E is used in concrete products for the purpose of controlling plastic shrinkage and thermal cracking.

ProCon-F-E meets the requirements of ASTM C-1116, Section 4.1.3 and AC-32 at 1.5 lb (0.68 kg) per CY.

Applications

ProCon-F-E utilizes the mixing activity to disperse the fibers into the mix. ProCon-F-E provides a multi-dimensional fiber network and does not affect curing process chemically.

ProCon-F-E can be used in all types of concrete. Fibrillated tape synthetic fibers help the concrete and can be used to replace light guage WWF, depending on the application

Mixing

ProCon-F-E can be added directly to the mixing system after the batching of the ingredients and mixed at high speed for a minimum of three minutes. The addition of ProCon-F-E at the normal recommended dosage rate of 1.5 lb/cy does not require any mix design or application changes. A water reducer or super-plasticizer is recommended in concrete products where improved workability and finishability are desired.

Tooling & Finishing

Fiber reinforced concrete can be finished by most finishing techniques.

ProCon-F-E mixes can be pumped and placed using conventional equipment. Hand screeds can be used, but vibratory and laser screeds are recommended to provide added compaction and bury surface fibers.

Packaging

(30) 1 lb (0.45 kg) bags per box, 600 lbs per pallet (20) 1.5 lb (0.68 kg) bags per box, 600 lbs per pallet

ProCon-F-E Fibers are packaged in pre-measured 1 lb or 1.5 lb degradable "toss-in" paper beater bags or water soluble bags.

Storage and Shelf Life ProCon-F-E should be stored in dry warehouse. Protect product from the rain.
